

- \*Tuition is due the first day of the week of attendance, not payable in arrears
- \*Tuition is due regardless of illness or other absence as binding by this contract
- \*Every enrolled family receives one week of vacation whereby tuition is not due
- \*Vacation must be taken consecutively to be unpaid
- \*A current enrollment form [jfs1234] must accompany this contract
- \*The Code of Conduct must be adhered to at all times during this contract period
