RELEASE POLICY

At the end of the day, students will **only** be released to a parent, guardian, or other authorized person listed on the release form. The school reserves the right to request picture identification of anyone picking up a child. **The school also reserves the right to withhold the release of any child if proper identification cannot be shown or verified.** We will always withhold the release of any child to **anyone suspected of driving under the influence or anyone displaying an inability to safely operate a motor vehicle.**

If you or someone authorized to pick up your child needs assistance due to special needs or circumstances, please notify us so that accommodations can be made.

It is extremely important that your child be picked up on time each day. Late pickup charges will be imposed at the rate of **\$2 per minute** past pickup time and are payable to the employee who stayed with your child/children. Late fees not paid to employees will be added to your tuition account balance.
